Recommendation to Reopen Chicago Police Department Disciplinary Investigation

Pursuant to the Municipal Code of Chicago (MCC) § 2-56-230(c)(ii), the Public Safety section of the City of Chicago Office of Inspector General (OIG) conducts reviews of individual closed disciplinary investigations conducted by the Civilian Office of Police Accountability (COPA) and the Chicago Police Department's (CPD) Bureau of Internal Affairs (BIA). Based on those reviews, OIG may make a recommendation to reopen the investigation to address a deficiency materially affecting its outcome.

BIA investigated allegations that Officer Saul Diaz, Star #17501, attempted to run the complainant off the road while the complainant was riding their bicycle. BIA reached a Not Sustained finding for the allegation.

While travelling to a call for shots fired, Officers Diaz and Daniel Gonzalez, Star #10364 encountered the complainant while the complainant was riding their bicycle near the driver's side of the CPD squad car. Officer Diaz tells the complainant, "You're on the wrong side of the street" and orders the complainant off their bike. The complainant and the officers exchange words—eventually the complainant provided their identifying information to the officers. Officer Gonzalez conducted a name check and issued the complainant an Administrative Notice of Violation for obstruction or interference with traffic.

During its review, OIG identified that BIA did not include an Investigatory Stop Report (ISR) in its electronic case file. OIG also identified that BIA did not address that Officer Diaz reached into the complainant's pants pockets and retrieved their cell phone potentially conducting an unlawful search.

OIG recommended BIA reopen the investigation to conduct an analysis of whether Officer Diaz conducted an unlawful search and whether the involved CPD members failed to complete an ISR.

In response to OIG's recommendations, BIA declined to reopen the investigation, stating "this case will not be re-opened to address completing an Investigatory Stop Report and removing the Reporting Party's cell phone from [their] pocket during a protective pat down search. This case is in Command Channel Review and near Closed Final."

Pursuant to § 2-56-230(c)(ii) of the Municipal Code of Chicago (MCC), the Office of Inspector General's (OIG) Public Safety section conducted a preliminary review of the investigation conducted by the Chicago Police Department's (CPD) Bureau of Internal Affairs (BIA) in Log #2023-0004677. OIG recommends that BIA reopen the investigation to fully account for all available evidence and conduct an analysis of all potential violations. Log #2023-0004677 is currently in a Command Channel Review status or has not reached a final disciplinary decision.

Log #2023-0004677 concerns allegations that CPD Officer Saul Diaz, Star #17501, attempted to run the complainant off the road while the complainant was riding their bicycle. BIA reached a Not Sustained finding for the allegation.

Per Event Query recorded under #2327614628, on October 3, 2023, at approximately 8:55 p.m., Officers Diaz and Daniel Gonzalez, Star #10364, were dispatched to a shots fired call. While en route, Officer Gonzalez's body worn camera (BWC) footage captures Officer Diaz driving a CPD squad car as the complainant rides their bicycle near the driver's side of the CPD squad car at approximately 8:56 p.m.²

Officer Diaz's BWC footage shows Officer Diaz activate the emergency equipment and exit the CPD squad car to initiate an investigatory stop on the complainant. Officer Diaz tells the complainant, "You're on the wrong side of the street. I tried to tell you that multiple times. Get off the bike." Officer Diaz grabs the complainant's wrist and again orders them to dismount from their bicycle before placing the complainant's hands on top of the CPD squad car's hood.³ Officer Rodriguez tells the

complainant, "The reason we're stopping you is you're all over the street. Then we ask you to get on the right side or pick a side and you chose the wrong side." The complainant responds, "You guys have nothing else to do?" Officer Gonzalez responds, "No." Officer Diaz orders the complainant to remove their backpack from their back and places the complainant in handcuffs. As Officer Diaz puts the complainant in handcuffs, the complainant questions why Officers are detaining them. Officer Gonzalez responds, "for riding your bicycle on the wrong side of the street." Officer Gonzalez asks the complainant if they have their identification, and the complainant responds, "I don't." The complainant tells Officers they were attempting to make a left turn on their bike because they were on their way to their residence. Officer Gonzalez questions why the complainant did not use hand signals to indicate the left turn. The complainant responds, "you guys didn't let me, you guys were about to run me over." Officer Diaz responds, "No, we were not."

Body Worn Camera footage shows Officer Diaz patting down the complainant's front right-side pants pocket before reaching into the complainant's pants pocket and retrieving a cell phone. The complainant tells Officers, "Again, I don't consent to any search or seizures – that's my phone. You hear me?" Officer Diaz places the cell phone on top of the hood of the CPD squad car, tells the complainant, "I can't hear you because your music is going" before turning the complainant's music off. On Officer Gonzalez's BWC footage, Officer Diaz is seen lifting the complainant's sweatshirt up to view their waistband before Officer Diaz pats down each of the complainant's pants pockets, the front pocket of the complainant's sweatshirt, and the complainant's waistband.

Officer Gonzalez asked the complainant for their identifying information, but the complainant requested that the Officers call their Sergeant to the scene. Officer Gonzalez dispatched "unrelated street stop" over the radio and provided their location. The complainant made a phone call to an unknown person and described the stop, asking the unknown person whether they should provide their identifying information to the Officers.⁸ The complainant stated to the unknown person on the phone, "They got me in handcuffs. I'm on my bike – they said it's because I wasn't on the bike lane. I'm telling ya, they're just fucking bored." Officer Diaz responded, "actually we were responding to a call of shots fired and you're in the – you're obstructing traffic, bro."

The complainant provided their first and last name, date of birth, and home address to Officer Gonzalez. The complainant again requested Officers call a Sergeant to the scene and stated they wanted to file a complaint before stating to Officer Diaz, "You almost hit me, dumbass." The complainant called Officer Diaz names and a homophobic slur and stated they were on their way home. The complainant told Officer Diaz, "Stop talking about you're responding to shots fired – then go to that. Instead of bothering somebody that's fucking riding a bike." Officer Diaz told the complainant they could not get through because the complainant was in the middle of the street. ¹⁰

Officer Gonzalez entered the CPD squad car and ran the complainant's information on the portable data terminal (PDT). Then, Officers Diaz and Gonzalez issued an Administrative Notice of Violation

(ANOV) to the complainant for obstruction or interference with traffic. Officer Gonzalez described the complainant's actions on the ANOV as, "Above subject was riding bicycle on the middle of two way street obstructing R/O's en route to call. R/O's advised to clear the street and move to a side of the street. Subject did not comply."¹¹

In their To From Subject Report (TFSR), Officer Diaz reported they were "responding to a shots fired call using emergency equipment lights/sirens" and "unable to proceed to call due to subject riding [their] bicycle in the middle of the street while blocking unmarked police vehicle and riding against motor vehicle traffic." ¹²

CPD's Special Order S04-13-09(VIII)(A)(1) requires sworn CPD members complete an Investigatory Stop Report (ISR) after conducting an investigatory stop, probable cause stop, or protective pat down or other search in a public place. Per S04-13-09(VIII)(A)(2), an ISR is required "for all Investigatory Stops and Protective Pat Downs that lead to an arrest, Personal Service Citation, Administrative Notice of Violation (ANOV), Curfew Violation Report, School Absentee Report, or other enforcement action." Additionally, under S04-13-09(VIII)(A)(3) sworn CPD members are "required to provide the subject of the stop a completed Investigatory Stop Receipt", which includes the event number, the reason for the stop, and the sworn member's name and star number. The electronic case file for Log #2023-0004677 does not contain an ISR completed by Officers Diaz and Gonzalez for the incident. Moreover, neither Officer Diaz nor Officer Gonzalez is observed on their BWC footage offering the complainant an ISR receipt. There is no documentation completed by Officers Diaz and Gonzalez to support the search of the complainant. Without any documentation describing the reasonable articulable suspicion for their actions, Officer Diaz appears to have conducted an improper search when they reached into the complainant's pants pocket and retrieved a cell phone.

Based on OIG's preliminary review, and without taking any position on any other aspect of the investigation or its findings, OIG recommends that BIA reopen Log #2023-0004677 to conduct an analysis of whether Officer Diaz conducted an unlawful search when they reached into the complainant's pocket and seized the complainant's cellphone, and lifted the complainant's sweatshirt to search their waistband. Also, BIA should consider addressing the Officers' failure to complete an ISR report and receipt and consider any other applicable violations.
